Warner Township Budget Meeting April 6, 2022 Minutes

Meeting was called to order at 7:01 p.m.

Pledge of allegiance Roll call: Present- Martin Franckowiak, Linda Franckowiak, Pam Zaremba, Lori Herman and Rob Herman. Absent: 0

Motion by L. Franckowiak to approve minutes. Supported by L. Herman

Road projects: Deadman's Hill road: Beginning at US 131 thence east and north to end of payment on Dobleski rd, approximately 6,180 feet. Work would include: reshape existing grade, place and compact 4 inches of 23A gravel 28 feet wide. Total estimated cost: \$41,000.

Deadman's Hill road: Beginning at US 131 thence west to end of county road, approximately 3,580 feet. Work would include: reshape existing grade, place and compact 4 inches of 23A gravel 28 feet wide. Total estimated cost: **\$30,000**.

Dobleski road (North) between paved section north of Thumm road approximately 9,270 feet. Work would include shaping existing grade place and compact three (3) inches of 23A gravel 30 feet wide. Total cost **\$52,000**.

Manglos road beginning at Gromeys road thence east to Mt. Jack road approximately 2,600 feet. Work would include shaping existing grade, place and compact three (3) inches of 23A gravel to cover existing width. Total cost **\$15,000**.

Total cost of road projects \$138,000. Warner Township has \$54,000. In road allocation to be used up in the 2022 year. That brings the proposed road projects to \$84,000.

Motion by P. Zaremba to approve the above road projects to be scheduled for the 2022 year. Supported by L. Herman.

Martin Franckowiak (supervisor) will call Burt at Antrim County road commission to schedule the above road projects to be done.

Regarding the road petition of opening Manglos road for a year round road, the board did discuss this matter and a roll call vote was voted on. To update and open Manglos road to a year round road. Lori-NO, Martin-NO, Linda-NO, Rob-NO, Pam-NO. Voted carried and did not pass. Current status-Manglos road will receive necessary road maintenance but will still remain a seasonal road.

The other issue on the petition was to install a street light at the intersection of Manglos rd and 131. A call was placed to Great Lakes Energy, in order to give a quote there is a \$75.00 fee to have an engineer come out and draw up a proposed plan. Motion by L. Herman to have Great Lakes draw up a proposal. Supported by L. Franckowiak.

Motion by P. Zaremba to approve Leona Dycus, Emily Dobrezlewski, Linda Franckowiak and Peggy Nowak as Election workers for the May 3, 2022 election. Supported by R. Herman.

Motion by L. Herman to pay the bills. Supported by L. Franckowiak.

Motion by R. Herman to purchase a paper shredder up to \$250.00 and not to exceed. Supported by M. Franckowiak.

Motion by R. Herman to adjourn the meeting. Supported by L. Franckowiak.
